
Total Assets (Rs. Trillion)





Assets managed by the Indian mutual fund industry has increased from Rs. 64.71 trillion in July 2024 to Rs. 77 trillion in July 2025. That represents 19.01% increase in assets over July 2024

Assets are measured as average assets for the month.

Rs. Trillion is equivalent to Rs. lac Cr.

Scheme wise Composition of Assets




The proportionate share of equity-oriented schemes is now 59.8% of the industry assets in July 2025,down from 59.9% in July 2024.

The proportionate share of debt-oriented schemes is 14.6% of industry assets in July 2025, same as in July 2024.

ETF market share is 12.3% in July 2025, down from 12.7% in July 2024

Liquid/ Money Market share is 13.2 % in July 2025, up from 12.8 in July 2024



Equity-oriented schemes include equity and balance funds.



Individual investors now hold a relatively low share of industry assets, i.e. 60.2% in July 2025, as compared to 61.0 % July 2024


Institutional investors account for 39.8% of the assets, of which corporates are 95%. The rest are Indian and foreign institutions and banks.



Institutions include domestic and foreign institutions and banks. HNIs are investors who invest with a ticket size of Rs.2 lakhs or above.

Investor Categories Across Scheme Types





Equity-oriented schemes derive 88% of their assets from individual investors (Retail + HNI)

Institutional investors dominate liquid and money market schemes (89%), debtoriented schemes (66%) and ETFs, FOFs (87%).


Composition of Investors' Holdings



Individual investors primarily hold equity-oriented schemes while institutions hold liquid, debtoriented schemes and ETFs, FoFs

87% of individual investor assets are held in equity-oriented schemes.

54% of institutions assets are held in liquid / money market schemes and debt-oriented schemes.





Growth in Assets



The value of assets held by individual investors in mutual funds increased from Rs.39.50 lac cr in July 2024 to Rs. 46.39 lac cr in July 2025, an increase of 17.45%.

The value of Institutional assets has increased from Rs.25.21 lac cr in July 24 to Rs.30.62 lac cr in July 2025 an increase of 21.44%.
